Instructions

Step One

Please write name, ID number and Branch (if applicable) and list the preferred instrument or subject. (Only one instrument/subject per form, please.)

Step Two

Please provide the appropriate documentation for all points listed in the section marked "Instrument/Subject Study." Additional verification may be required for incomplete documentation.

The instruction referred to below pertains *only* to instrument studies that you have completed as a student in an individual study setting. *It does not pertain to your teaching experience*.

- ➤ For college courses or degrees completed within the U.S., MTAC requires official transcripts to be sent from the college directly to the State Office. *Electronic or student copies will not be accepted*.
- ➤ For college courses completed outside of the U.S., MTAC requires a course-by-course Foreign Credential Evaluation Report (FCER) from a NACES-approved evaluation agency. *No other documentation will be accepted.* For qualifying evaluation agencies, please visit <u>naces.org</u>.
- For private instruction, please have your instructor mail us a signed, dated letter including their full contact information and dates of instruction, as well as level or repertoire completed.
- A minimum of 12 points (*equivalent to two years*) of study are required to add an instrument or subject.

Step Three

Please indicate that you agree to all of the terms at the bottom of the form and sign.

Step Four

Current MTAC members should enclose an application fee of \$50. This fee is waived for new applicants to MTAC.
